ARTICLES OF ORGANIZATION FOR MFFA&C LIMITED COMPANY a Florida Limited Liability Company 95 NOV 14 AM 9:09

The undersigned, descring to form a limited liability Company under and pursuant to Florida Statute 608 and entitled the Florida Limited Liability Company Act do hereby adopt the following of Articles of Organization for such company:

- 1. Name. The name of the Company shall be MFFA&C LIMITED COMPANY.
- 2. <u>Duration/Continuation</u>. The period of the Company's duration shall be 29 years from the date of filing of these Articles of Organization with the Florida Secretary of State unless terminated earlier by the unanimous written agreement of all members or by the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member unless the business of the Company is continued by the consent of all the remaining members or by an amendment of these Articles of Organization providing for the continued existence of the Company subsequent to the foregoing events.
- 3. <u>Mailing Address</u>. The mailing address of the limited liability Company is c/o of Fred DelGuidice, 1101 North Lake Destiny Drive, Suite 400, Maitland, Florida 32751.
- 4. Registered Agent and Office. The name and street address of the initial registered agent and office of this Company is Fred DelGuidice, 1101 North Lake Destiny Drive, Suite 400, Maitland, Florida 32751.
- 5. Admission of Additional Members and Terms and Conditions of Such Admissions. Additional members may be admitted upon the approval of the majority of the members of the Company, upon the written application of such new member in a manner set forth in bylaws of this Company.
- 6. Right to Continue Business. The remaining members may continue the business on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company.
- 7. Management of the Company. The business of the Company shall initially be managed by Mildred DelGuidice who shall serve as manager/president until the first annual meeting of the Members or until her successor is elected and qualified. Management of the Company is reserved to the Members. Mildred DelGuidice's address is 1101 North Lake Destiny Drive, Suite 400, Maitland, Florida 32751.

10. Purposes of the Company. The Company is formed for the purposes of performing any and all business which is lawful under the laws of the State of Florida including, without limitation, the acquisition and management and eventual conveyance of real property. The limited liability Company shall have all the powers as set forth in Florida Statutes 608.404.

- 11. Amendment of Articles of Organization. Any amendment to these Articles of Organization shall be on such form prescribed by the Secretary of State of the State of Florida containing such terms and provisions consisting with Florida Statutes 608 and shall be prescribed by the Department of State and shall be signed and sworn to by all Members of the Company. In the event a new member is added by such amendment it shall also be signed by the member to be added.
- 12. Regulations of Company. The power to adopt, alter, amend or repeal the regulations of the limited liability Company should be vested in the Members. Regulations adopted by the Members may be repealed or altered, new regulations may be adopted by the Members and the Members may prescribe that any regulations made by them that such regulations may not be altered, amended or repealed by the managers.
- 13. Transferability of Member's Interest. An interest of a member of this Company may be transferred or assigned to such extent and in a manner provided in the regulatory agreement. However, if all the remaining members of the Company do not approve of such proposed transfer or assignment by unanimous written consent, the transferee of the interest of such member shall have no right to participate in the management of the business and

affairs of the Company or to become member. The transferee shall be entitled to receive only the share of profits or other compensation by way of income and the return of contributions to which that member otherwise would be entitled.

- 14. <u>Withdraw Reduction of Member's Contribution Capital</u>. A Member shall not receive out of the Company property any part of his or her contribution to capital until:
- (a) all liabilities to the Company have been paid or sufficient to the property of the Company remains to pay them.
 - (b) The consent of all Members is obtained.
- (c) These Articles of Organization are cancelled or so amended as to set out the withdraw reduction.
- A Member shall be entitled to a return of their contribution in a manner provided for in the regulations of the Company.
- 15. <u>Capital</u>. The capital of the Company shall initially be \$1,000.00 and will be contributed in accordance with each Member's respective Percentage Interest.
- 16. <u>Distributions</u>. There will be a special distribution of one hundred percent (100%) of all net income of this limited liability company to the Manager/President for as long as Fred DelGuidice is alive. Upon the demise of Fred DelGuidice, all net income will be distributed in accordance with the Percentage Interest of each Member as set forth in paragraph 9 above.
