TO  
ARTICLES OF ORGANIZATION  
OF

Pursuant to the provision of Section 608.411, Florida Statutes, the undersigned limited liability company adopts the following Articles of Amendment to its Articles of Organization and swears to the following:

FIRST: The name of the limited liability company is: Westwind Insurance Services, L.C.

SECOND: The Articles of Organization of the limited liability company were filed by the Secretary of State of the State of Florida on November 28, 1995.

THIRD: The following amendment to the Articles of Organization was adopted by the limited liability company: Article 1 of the Articles of Organization shall be deleted in its entirety as of the date hereof and the Article 1 set forth below shall be substituted in its place.

FOURTH: As amended below, Article 1 of the Articles of Organization has the sole effect of changing the limited liability company's name from "Westwind Insurance Services, L.C." to "Gateway Transportation Underwriters, L.C."

FIFTH: This amendment to the Articles of Organization was adopted by the members of the limited liability company as of Mar 29, 1999.
