The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I

Name, Registered Office and
Registered Agent

The name of this company is THE TAX AND BUSINESS DOCTORS, L.C.

The address of the registered office of this company and the agent at said address is Jeanette G. Davis, 809 Eastover Circle, DeLand, FL 32724.

ARTICLE II

Duration

The company shall commence its existence on January 1, 1996, or the date these Articles of Organization are filed by the Florida Department of State, whichever is later. The Company's existence shall terminate not later than December 31, 2050, unless the Company is earlier dissolved as provided in these Articles of Organization.

ARTICLE III

Purpose and Powers

1. Purposes. Excepted as restricted by these Articles of Organization, the limited liability company is organized for any legal and lawful purpose for which a limited liability company may be organized pursuant to Florida Statutes.

2. General Powers Section. Except as restricted in these Articles of Organization, the limited liability company shall have and may exercise all powers and rights which a limited liability company may exercise legally pursuant to Florida Statutes.

ARTICLE IV

ARTICLE IV

Additional Capital Contributions

Each member shall make additional capital contributions to the Company, if such contributions are needed by the Company as provided in the Regulations, upon the request of a member or a manager. The cumulative total of such additional contributions paid by a member shall not exceed \$2,500.00.

ARTICLE V

Admission of New Members

No additional members shall be admitted to the Company except with the unanimous consent of all the members of the Company and upon such terms and conditions as shall be determined by the members. A member may transfer his or her interest in the Company as set forth in the Regulations. The transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

ARTICLE VI

Management

The Company shall be managed by a manager or managers in accordance with the Regulations adopted by the members for the management of the business and affairs of the Company. Such Regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. 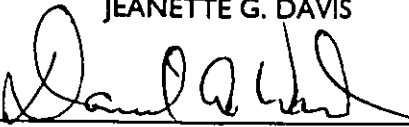
ARTICLE VII

The limited liability company reserves the right to amend its Articles of Organization from time to time in accordance with Florida Statutes.

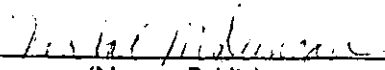

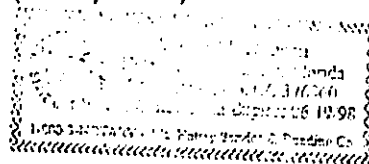

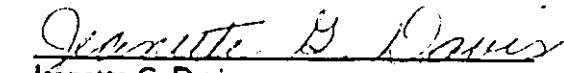
