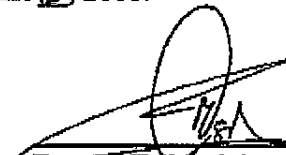

**ARTICLES OF DISSOLUTION****OF****M.T.E., L.C.**

Pursuant to the provisions of Section 608.445 of the Florida Limited Liability Company Act, these Articles of Dissolution provide that:

1. The name of the limited liability company is M.T.E., L.C. (the "Company").
2. The effective date of the Company's dissolution is March 15, 1997.
3. The occurrence that resulted in the Company's dissolution pursuant to Section 608.441 is the death of a non-corporate member on December 15, 1996 and the majority of the remaining members did not consent to continue the business of the Company as provided in the Company's Operating Agreement.
4. All debts, obligations and liabilities of the Company have been paid or discharged.
5. All remaining property and assets have been distributed among its members in accordance with their respective rights and interests.
6. There are no suits pending against the Company in any court.
