ARTICLES OF ORGANIZATION  
OF

The undersigned, desiring to form a limited liability company pursuant to the provisions of the Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes (the "Act") hereby adopt the following Articles of Organization:

1. Name. The name of the limited liability company is FLORIDA INSURANCE AND SURETY GROUP, L.C. (the "Company").
2. Mailing Address and Principal Office. The mailing address and principal business office of the Company within the State of Florida shall be 1901 Lee Road, Winter Park, Florida 32789.
3. Duration. The existence of the Company shall commence on the date of the filing of these Articles of Organization with the Florida Department of State, and it shall remain in existence until the first to occur of the following:
  - (a) December 31, 2050;
  - (b) Dissolution of the Company pursuant to the terms of the Operating Agreement between its Members; or
  - (c) Dissolution of the Company pursuant to the Act.
4. Purpose. Subject to the terms of the Operating Agreement between its Members, the purpose for which the Company is organized is to engage in any and all lawful business

activities for which limited liability companies may be organized under the Act.

5. Admittance of New Members. New Members may be admitted and existing Members may transfer their interests to other Members subject to compliance with the terms of the Operating Agreement between the Members. New Members may be admitted only upon the consent of a majority of the Members. Existing Members may transfer their interest to a new Member only upon the unanimous consent of all of the non-transferring Members.

6. Registered Agent. The name of the initial registered agent of the Company shall be Michael E. Neukamm, whose address is Gray, Harris & Robinson, P.A., 201 E. Pine Street, Suite 1200, Orlando, Florida 32801.

7. Management. The Company is to be managed by Managers who shall be elected in accordance with the terms of the Operating Agreement and the Company's Regulations, and who shall have such responsibilities as provided therein. The names and addresses of the persons who shall serve as the Managers of the Company until the first annual meeting of Members, or until (whichever is earlier) their successors are elected and qualified, are as follows:

- (a) Terry James

- (b) James Breen

The authority of the Managers, or any of them, to bind the Company is limited by the provisions of its Regulations and the terms of the Operating Agreement between the Members.

8. Continuity of Business. Upon the death, retirement, resignation, expulsion, withdrawal, bankruptcy or dissolution of a Member, the Company shall be dissolved unless, within ninety (90) days of such event, all the remaining Members of the Company consent, in writing, to continue the business of the Company.

#### AFFIDAVIT OF MEMBERSHIP AND CONTRIBUTIONS

The undersigned authorized representative of a Member of the Company hereby deposes and says:

1. The Company has at least two Members.
2. The total amount of cash and the value of property initially contributed and anticipated to be contributed by the Members is \$100.

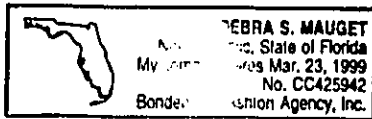
