

Please be advised that we represent Mr. and Mrs. Kenneth Elliott, the Managing Partners of Lost Lakes of Cocoa, L.C. Our clients purchased this limited liability company or about May 14, 1996. On or about March 12, 1996, this firm contacted the Florida Secretary of State requesting instructions as to what was required to be done regarding the purchase of this company. We were informed of the procedure for filing an amendment to the Articles of Organization and accomplished that on May 21, 1996. In June of this year, we received a letter from the Department of State confirming the filing of the Amended and Restated Articles of Organization. I have enclosed a copy of that letter for your information. Even though we have several telephone conversations with your office, at no time were we informed that the annual report was due or delinquent. In addition, our clients never received written notification from your office that the annual report was delinquent or due either before or after the Amended and Restated Articles were filed.
