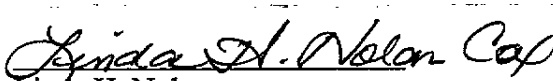
Adequate provision has been made regarding any debts, obligations and liabilities of the Company according to Section 608.4421, Fla. Stat.

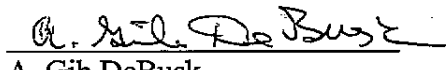
Remaining property and assets of the Company have been distributed according to law.

There are no suits pending against the Company in any court.

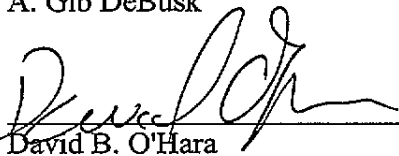
