ARTICLE 1 - NAME

The name of the limited liability company is: HADAD ONE LIMITED COMPANY, hereinafter simply referred to as the "Company".

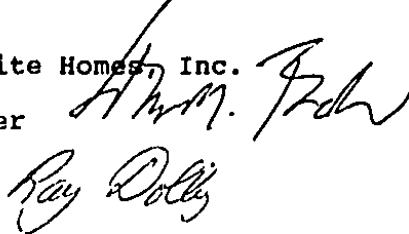
