**ARTICLES OF ORGANIZATION
OF
TAMA BROADCASTING GROUP OF FLORIDA, L.C.**

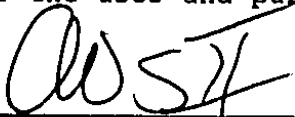
The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, . F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

1. The name of the limited liability company is **TAMA BROADCASTING GROUP OF FLORIDA, L.C.** (Company). The principal place of business of the Company in Florida shall be 121 NW 6th Ave., Fort Lauderdale, FL 33311.
2. The Company shall commence its existence on the date the Articles of Organization are filed by the Florida Department of State. The Company's existence shall terminate not later than August 6, 2025, unless the Company is dissolved earlier as provided in these Articles of Organization.
3. The general purpose for which the Company is organized is to purchase and operate media properties and to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.
4. The name and the street address of the registered agent of the Company in the State of Florida is Charles W. Cherry II, 121 NW 6th Ave., Fort Lauderdale, FL, 33311.
5. The members of the Company shall contribute to the capital of the Company the cash or property set forth in Exhibit A.
6. Each member shall make additional capital contribution to the Company only upon the unanimous consent of all the members.
7. No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and upon such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.
8. The Company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or manager, or upon the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there are at least two remaining members.
9. The Company shall be managed by the members in accordance with the regulations adopted by the members for the management of the

business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
