**FIRST:** The date of filing of the Articles of Organization was January 24, 1996.

**SECOND:** These Amended and Restated Articles of Organization, which amend and restate the original Articles of Organization, were duly executed and are being filed in accordance with Section 608.411 of the Florida Limited Liability Company Act.


**THIRD:** The text of the Articles of Organization is hereby amended and restated to read in its entirety as follows:

1. The name of the limited liability company is TAMA GROUP, L.C. (the "Company"). The mailing address and the street address of the principal office of the Company shall be 5207 Washington Boulevard, Tampa, Florida 33619.
