A FLORIDA LIMITED LIABILITY COMPANY
FILED PURSUANT TO FLORIDA STATUTE \$608.407

ARTICLE I

The name of the Company is Anspach Realty, L.C.

ARTICLE II

The mailing and street address of the principal office of the Company is 725 E. Osceola Boulevard, Stuart, Florida 34994

ARTICLE III

The period of duration for the Company is for an initial forty (40) year term from the date of filing of these Articles unless sooner terminated or extended in accordance with the Operating Agreement.

ARTICLE IV

The Company is to be managed by its members whose name and address are:

William E. Anspach, III, M.D. and Cecilia Anspach, M.D., tenants by entirety 725 E. Osceola Boulevard Stuart, Florida 34994

The consent of each member shall be required in the management of the Company.

ARTICLE V

No right is given to any member to admit additional members without the consent of all members and then only in accordance with the Operating Agreement.

ARTICLE VI

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which pursuant to the Operating Agreement or state law terminates the continued membership of a member in the Company, the remaining members may, by unanimous vote, within ninety (90) days, elect to continue the business of the Company. The member or members shall forthwith execute and record an amendment to the Articles of Organization to evidence such continuation, if required by appropriate governing law.

ARTICLE VII

A member may not assign or transfer any portion of its interest in the Company without the prior written, unanimous approval of the remaining members and then only in accordance with the Operating Agreement.

ARTICLE VIII

The net profits and losses of the Company for any year shall be allocated among the members in accordance with the Operating Agreement.

ARTICLE IX

The initial Registered Agent to accept service of process on the Company is Mark J. Nowicki, 14155 U.S. Highway One, Suite 302, Juno Beach, Florida 33408-1499.
