Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation, a Florida limited liability company (the "Company"), hereby adopts the following Articles of Amendment (this "Amendment").

1. **Company Name.** The name of the limited liability company is Allstate Petroleum, L.C. The original date of filing the articles of organization was January 30, 1996.
2. **Amendments Adopted.** This Amendment provides for the Company's change of name.
3. **Text of Amendment.**

Article I of the Articles of Organization entitled Name is hereby deleted in its entirety and the following Article I shall be substituted in for Article I:


ARTICLE I - NAME
