The undersigned, acting as organizers of GRUPO INTERAMERICA, L.C., under the Florida Statutes adopt the following Articles of Organization of a limited liability company as of January 4, 1996.

Article 1

Name of Company

The name of the limited liability company shall be GRUPO INTERAMERICA, L.C., and shall be hereinafter referred to as the "Company."

Article 2

Period of Duration

The period of duration is thirty (30) years from the date of filing of these Articles of Organization with the Florida Secretary of State, unless the Company is sooner dissolved.

Article 3

Purpose

The Company is organized for any legal and lawful purpose pursuant to the Florida Statutes and pursuant to agreement by the members.

Article 4

Principal Office

Article 6

Initial Capitalization

The initial amount of contribution is \$400.00 which be contributed in equal portions by the undersigned initial members.

Article 7

Management

The Company shall be managed by the members and no manager will be appointed. The undersigned are the initial members with their respective addresses listed beneath their signatures.

Article 8
Additional Members

The members have the right to admit additional members upon the unanimous consent of all current members.

Article 9
Continuation Upon Withdrawal of a Member
