# Articles of Organization of LYNN ALLEN ORGANIZATION, L.C.

## ARTICLE I

The name of the limited liability company shall be LYNN ALLEN ORGANIZATION, L.C. (the "Company").

## ARTICLE II

The mailing and physical address of the Company's principal office shall be 350 Mayfair Circle East, Palm Harbor, Pinellas County, Florida 34683.

## ARTICLE III

The period of duration for the Company shall be perpetual, and the formation of the existence of the Company shall be deemed to begin on the date upon which any manager or managers named herein conduct business under the name of or on behalf of the Company, or upon the date these Articles of Organization are filed by the Florida Department of State, whichever occurs first.

## ARTICLE IV

The name of the Company's initial registered agent in Florida shall be: James L. Clark, Esquire. The address of the Company's registered office shall be: 201 North MacDill Avenue, Tampa, Florida 33609.

## ARTICLE V

The Company shall be managed by (Managers):

**STEPHEN L. STUDNICKA**

**RICK HAGG**

The initial manager of the Company shall be STEPHEN L. STUDNICKA, whose address is 350 Mayfair Circle East, Palm Harbor, Florida 34683. and who shall serve as initial manager until the

first annual meeting of the members.

#### **ARTICLE VI**

Members of the Company shall have the right to admit new members, subject to the terms and conditions of the regulations, as they may be promulgated from time to time. However, no member's interest in the Company shall be sold, transferred, assigned, pledged or otherwise affected, and no additional members shall be admitted, without the unanimous written consent of the existing members. The existing members shall determine the amount and nature of contributions by an additional member and any terms and conditions of such membership, as and for consideration to be admitted as a member of the Company.


#### **ARTICLE VII**

The remaining members of the Company shall have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The terms and conditions of the right to continue the business of the Company shall be in accordance with the regulations, as may be promulgated from time to time, but such continuation of business of the Company shall be subject to the unanimous written consent of the remaining members.

#### **ARTICLE VIII**

The power to adopt, alter, amend or repeal the regulations of the Company shall be vested entirely in the managers listed in Article V above.
