## EXHIBIT A

FIRST: Article IV of the Articles of Organization is hereby amended by deleting the existing Article IV in its entirety.

SECOND: ARTICLE VIII of the Articles of Organization is hereby amended by deleting the existing Article VIII and replacing it with the following:

"VIII: The term of the Company shall continue in full force and effect until December 31, 2100, unless the Company is earlier dissolved in accordance with regulations adopted by the members."

THIRD: Article III of the Articles of Organization is hereby amended by deleting the existing Article III and replacing it with the following:

"III: All limited liability company powers shall be exercised by or under the authority of, and the business and affairs of this limited liability company shall be managed under the direction of, the manager of this limited liability company, and such manager's name and address are as follows: Henderson Group, Inc., a Pennsylvania corporation, 112 Chesley Drive, Suite 200. Media, PA 19063."
