**CERTIFICATE OF AMENDMENT
OF THE ARTICLES OF ORGANIZATION OF
WORKSITE COMMUNICATIONS, L.C.
A LIMITED LIABILITY COMPANY
Original Filing Date: March 14, 1996**

Pursuant to the provisions of Sections 608.411 and 608.432 of the Florida Business Corporation Act, Florida Statutes (1997), the undersigned limited liability company hereby files this Certificate of Amendment of:

1. The name of the Limited Liability Company is: **Worksite Communications, L.C.**
2. The date of filing of the Articles of Organization was March 14, 1996.
3. The following Amendment to the company's Articles of Organization were adopted and subscribed to pursuant to an affirmative vote of the holders of not less than fifty-one (51%) percent of the then existing contributed capital of the company at a special meeting of the members, with notice of the proposed alteration, amendment, addition or repeal having been contained in the notice of the meeting, all in accordance with the provisions of Article XI of the Articles of Organization and Sections 408.411 and 408.432 (Florida Statutes, 1997).
4. The effective date of the amendment is August 1, 1999.
5. Pursuant to the provisions of Florida Statutes as above stated, Article IV of the Articles of Organization of Worksite Communications, L.C. is amended to read as follows:

**ARTICLE VII
PROFITS AND LOSSES**

(a) **Profit Sharing.** The members shall be entitled to the net profits arising from the operation of the limited liability company business that remain after the payment of the expenses of conducting the business of the limited liability company. Each member shall be entitled to the distributive share of the profits specified as follows:



Mike Sheridan	60%
Joe Gaudino	40%

The above-stated distributive shares may be changed from time to time by the affirmative vote of the holders of not less than fifty-one (51%) percent of the then existing contributed capital of the company.

The distributive share of the profits shall be determined and paid to the members no later than sixty (60) days after December 31st or the limited liability company's fiscal year, whichever is later.

(b) **Losses.** All losses that occur in the operation of the limited liability company business shall be paid out of the capital of the limited liability company and the profits of the business, or, if these sources are insufficient to cover such losses, by the members in the same proportion as net profits are distributed pursuant to subparagraph (a) of this Article VII.
