ARTICLES OF ORGANIZATION

OF

C.N.C., L.C.

FIRST: The date of filing of the articles of organization was March 14, 1996.

SECOND: The following amendments to the articles of organization were adopted by the limited liability company:

(a) Article VII of the Articles of Organization is deleted and the following new Article VII is substituted in its place to read as follows:

"ARTICLE VII PROFITS AND LOSSES

(a) <u>Profit Sharing</u>. The member shall be entitled to the net profits arising from the operation of the limited liability company business that remain after the payment of the expenses of conducting the business of the limited liability company. The member shall be entitled to the distributive share of profits as follows:

(1) to GLT TRUST: 100%

The distributive share of the profits shall be determined and paid to the member each year on the anniversary date of the commencement of business of the limited liability company, the month and day of the commencement date being the date of filing of the original Articles of Organization with the Florida Secretary of State.

- (b) <u>Losses</u>: All losses that occur in the operation of the limited liability company business shall be paid out of the capital of the limited liability company and the profits of the business, or, if these sources are insufficient to cover such losses, by the member in the following shares:
 - (1) GLT TRUST: 100%."
- (b) A new article to be designated Article X is hereby added to the Articles of Organization to read as follows:

"ARTICLE X DESIGNATION OF OFFICERS

The member or members of this limited liability company shall have the right from time to time in his or their sole and absolute discretion to engage and appoint individuals to serve as officers of this company. Such officers shall serve at the pleasure of the member or members who may terminate their services at any time. The initial officers shall be:
