OF

The undersigned members adopt the following Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act (the "Act").

ARTICLE I NAME OF COMPANY

The name of the limited liability company is PORT DEVELOPERS, L.C. (the "Company").

ARTICLE II PURPOSE

The general purpose for which the Company is organized is to transact any and all lewful business.
