## ARTICLES OF ORGANIZATION

OF  
GGB GROUP, L.C.  
A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, in forming a Florida Limited Liability Company ("Company") under the Florida Limited Liability Company Act, Chapter 608, of the Florida Statutes, hereby adopt the following Articles of Organization for such Company:

### ARTICLE I - NAME

The name of the Company is GGB GROUP, L.C.

### ARTICLE II - DURATION

The existence of the Company shall commence as of the date these Articles of Organization are filed by the Department of State and shall continue for a period of thirty (30) years from that date.

### ARTICLE III - ADDRESS

The mailing address and the street address of the principal office of the Company is 500 N.W. 62nd Street, 5th Floor, Fort Lauderdale, Florida 33309.

### ARTICLE IV - REGISTERED AGENT

The name of the initial Registered Agent of the Company is Lee H. Burg, Esquire, c/o Becker & Poliakoff, P.A., 3111 Stirling Road, Fort Lauderdale, FL 33312.

### ARTICLE V - ADDITIONAL MEMBERS

Additional Members may be admitted to the Company only upon the unanimous written consent of all of the then existing Members of the Company, which consent may be reasonably withheld.

### ARTICLE VI - RIGHT OF REMAINING MEMBERS TO CONTINUE BUSINESS

In the event of the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company, the business of the Company shall continue.

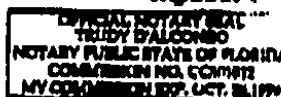
