#### **ARTICLES OF ORGANIZATION**

## FLORIDA MOBILE HOME FINDERS, L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

#### **ARTICLE I. - NAME**

The name of the limited liability company shall be FLORIDA MOBILE HOME FINDERS, L. C. (hereinafter referred to as "Company"). The principal place of business of the Company shall be Pelican Bays, 4990 S.W. 52nd Street, Suite 201, Davie, Florida 33314.

#### **ARTICLE II. - DURATION**

The Company shall commence its existence on the date these Articles of
Organization are filed by the Florida Department of State. The Company's existence
shall be for a period of fifty (50) years, unless the Company is dissolved as provided in
these Articles of Organization.

#### ARTICLES III. - PURPOSES AND POWERS

The general purpose for which the Company is organized is to broker the sale of mobile homes and to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

## ARTICLE IV. - REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the Company in the State of Florida is Tom Meyers, Pelican Bays, 4990 S.W. 52nd Street, Suite 201, Davie, Florida 33314.

# ARTICLE V. - ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the Company except without the written consent of the members of the Company owning at least sixty-six percent (66%) of the limited liability company interest in both capital and profits and upon such terms and conditions as shall be determined by the members. A member may transfer his or her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become or exercise any rights of a member without the written consent of the members of the Company owning at least sixty-six percent (66%) of the limited

liability company interest in both capital and profits of the Company then owned by the non-transferring members, which consent may be withheld by a Member in his or her sole and unrestricted discretion.

# ARTICLE VI. - TERMINATION OF EXISTENCE

The Company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or upon the occurrence of any other event that terminates the continued membership of a member of the Company, unless the business of the Company is continued by the consent of the remaining members owning at least sixty-six percent (66%) of the limited liability company interest in both capital and profits of the Company, provided there are at least two remaining members.

## ARTICLE VII. - MANAGEMENT

The Company shall be managed by the members in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
