## AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF WESTMINSTER HOMES L.C.

These Amended and Restated Articles of Organization, to be effective upon filing, are entered into, executed and filed pursuant to Section 608.411 of the Florida Limited Liability Company Act (the "Act") for the purpose of amending and restating the Articles of Organization, dated as of January 24, 1996 and filed with the Florida Department of State on or about January 26, 1996.

FIRST:

The name of the limited liability company is WESTMINSTER HOMES L.C. (the

"Company").

SECOND:

The purposes for which the Company is formed are as follows:

- A. To acquire, develop, construct, own, manage, finance, lease or otherwise deal with real estate on its own behalf or on behalf of other persons or entities;




