**ARTICLES OF ORGANIZATION
FOR
WHOLESALE WORLD, L.C.**

The undersigned has executed these Articles of Organization for the purpose of forming a limited liability company under the laws of the State of Florida.

- Article 1.** The name of the limited liability company is "Wholesale World, L.C." (the "Limited Liability Company").
- Article 2.** The term of duration of the Limited Liability Company shall be sixty (60) years ending December 31, 2055, unless sooner terminated in accordance with the Operating Agreement of the Limited Liability Company.
- Article 3.** The mailing address and principal office for the Limited Liability Company is 2808 N.W. 112th Avenue, Miami, Florida 33172.
- Article 4.** The name and address of the initial registered agent of the Limited Liability Company is Corporation Company of Miami, 1500 Miami Center, 201 S. Biscayne Boulevard, Miami, Florida 33131.
- Article 5.** Additional members may be admitted to the Limited Liability Company upon the unanimous consent of all existing members of the Limited Liability Company.
- Article 6.** The business of the Limited Liability Company may be continued after the death, bankruptcy, insanity, withdrawal or dissolution of a Member of the Limited Liability Company, or other event causing the dissolution of the Limited Liability Company if, within ninety (90) days after such event, the remaining members of the Limited Liability Company elect to continue the business of the Limited Liability Company.
- Article 7.** The business of the Limited Liability Company initially shall be managed by Augusto Nucci (the "Manager"). The address of the Manager is 3767 Pine Lakes Drive, Windmill Lake Estates, Ft. Lauderdale, Florida 33332-2101.
