ARTICLES OF ORGANIZATION OF FIRST NETWORK MANAGEMENT GROUP, L.C.

ARTICLE I

Name

The name of the limited liability company ("Company") is First Network Management Group, L.C.

ARTICLE II

Address

The mailing and street address of the Company's principal office is 1086 Cavern Drive Apopka, FL 32712.

ARTICLE III

Duration

The Company shall dissolve on the occurrence of one of the following events:

1. Unanimous written agreement of all members to dissolve.
2. A member's death, bankruptcy dissolution or any other event of dissociation, unless the company is continued by consent of all remaining members.
3. The Corporation has fewer than two members; or
4. A court decrees dissolution.

ARTICLE IV

Registered Agent and Office

ARTICLE V

Management

Admission of New Members

The remaining members of the Company may have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued only on the written consent of a majority of the remaining members.
