**ARTICLES OF ORGANIZATION**

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

**1. NAME.**

EFFECTIVE DATE

The name of the Limited Liability Company is: 5-13-96  
Bridgewater Coaches, L.C.

**2. PERIOD OF DURATION.**

The period of duration of the Limited Liability Company shall be from the effective date until the first to occur of the following:

(i) Thirty years from the effective date of these Articles of Organization, or

(ii) Dissolution of the Limited Liability Company pursuant to provisions of the Florida Limited Liability Company Act or pursuant to the Articles of Organization of the Limited Liability Company.

**3. PURPOSE.**

The purpose for which the Limited Liability Company is organized is to engage in any and all businesses and activities permitted by the laws of the State of Florida. The Limited Liability Company shall have all of the powers vested in a Limited Liability Company organized and existing by virtue of such laws.

**4. ADDRESS OF PLACE OF BUSINESS.**

**5. REGISTERED AGENT.**

6. CAPITAL CONTRIBUTION.

The total amount of cash, and a description of the agreed value of property other than cash, contributed to the Limited Liability Company is as follows: cash is being contributed to the Limited Liability Company for a total aggregate capital contribution of \$1,500.

7. ADDITIONAL CONTRIBUTIONS.

The total additional contributions, if any, agreed to be made by all members and the times at which, or the events upon the happening of which, they shall be made, are as follow: No additional contributions have been agreed to at the date of filing of these Articles of Organization. Additional contributions, if any, will be made upon agreement by a majority of the members of the Limited Liability Company.

8. ADDITIONAL MEMBERS.

9. CONTINUITY OF BUSINESS.

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Limited Liability Company, the business of the Limited Liability Company shall not be continued and the Limited Liability Company shall be dissolved unless there is obtained the consent of all the remaining members of the Limited Liability Company.

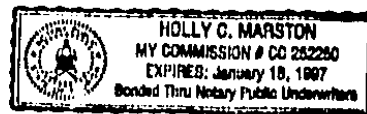
