ARTICLES OF ORGANIZATION OF DIXON/RUSSELL, L.C.

The undersigned adopt the following Articles of Organization for the purpose of becoming a limited liability company under the Florida Limited Liability Company Act, effective MAY 9, 1996.

ARTICLE I

Mamo

The name of the limited liability company, referred to in these Articles as "company," is DIXON/RUSSELL, L.C.
