The mailing address and street address of the principal office of the Company is 600 Lucien Way, Suite 100, Maitland, Florida 32751.

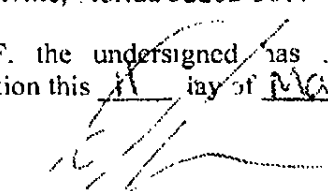

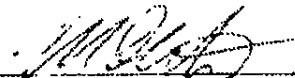
ACCEPTANCE OF APPOINTMENT BY INITIAL REGISTERED AGENT
