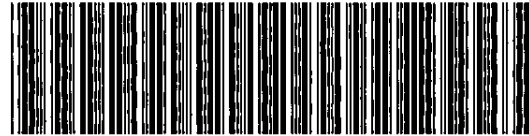



7. There are no suits pending against GRANDVIEW PREPARATORY SCHOOL, L.C., a Florida limited liability company, in any court whatsoever.


