ARTICLES OF ORGANIZATION FOR JET LEASING, L.C.

These Articles of Organization are for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, Sections 608.401-608.514, Florida Statutes (1995) (the "Act").

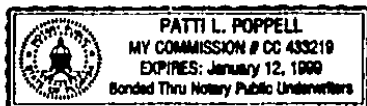
