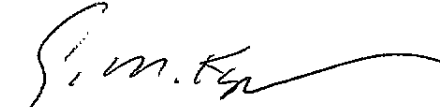

BGI, L.C.

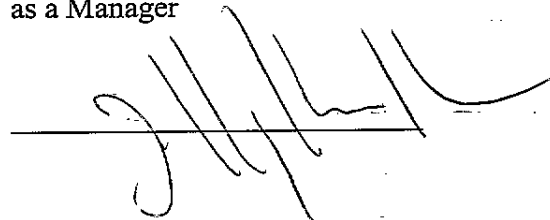
