# ARTICLES OF ORGANIZATION OF VIKING PARTNERS, L.C., A FLORIDA LIMITED LIABILITY CORPORATION

#### ARTICLE I - NAME

The name of the limited liability company shall be VIKING PARTNERS, L.C.
