**ARTICLES OF ORGANIZATION
OF

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under Chapter 608, Florida Statutes, the Florida Limited Liability Company Act.

Article 1 – Name

The name of the limited liability company is Exectech of America, L.C. ("Company").

Article 2 – Address

The mailing address and street address of the principal office of the Company is 3000 Olson Road, Tallahassee, Florida 32308.

Article 3 – Duration

The Company shall exist from the date of filing these Articles with the Department of State until the earlier of thirty (30) years from the date of filing or the occurrence of any of the events specified in Section 608.441, Florida Statutes, unless continued by the members pursuant to Company regulations.

Article 4 – Registered Agent and Office

The name of the initial registered agent of the Company is Adam Levinson. The street address of the initial registered agent of the Company is 3000 Olson Road, Tallahassee, Florida 32308.

Article 5 – Admission of Additional Members

Additional members may be admitted to the Company pursuant to Company regulations.

Article 6 – Termination of Membership

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may continue the business of the Company pursuant to Company regulations.

Article 7 – Management of the Company

The management of the Company is reserved to the members. The following are the initial managing members:




