The undersigned subscriber to these Articles of Organization, a natural person competent to contract, hereby undertakes to form a Limited Liability Company under the Laws of the State of Florida.

**ARTICLE I - NAME**

**ARTICLE II - NATURE OF BUSINESS**

The general character or nature of the business to be transacted by this Limited Liability Company is to engage in any and all business permitted under the laws of the State of Florida.

**ARTICLE III - INITIAL REGISTERED OFFICE AND AGENT**

#### ARTICLE VI - CONTRIBUTIONS

The total amount of cash contributed to the Limited Liability Company is Ten Thousand Dollars (\$10,000.00). No other property is being contributed to the Limited Liability Company.

#### ARTICLE VII - ADDITIONAL CONTRIBUTIONS

The total additional contributions, if any, agreed to be made by all members and the times at which, or the events upon the happening of which, shall be made as follows: No additional contributions have been agreed upon as of the date of filing of these Articles of Organization. Additional contributions, if any, will be made upon the unanimous written consent of the members of the Limited Liability Company.

#### ARTICLE VIII

Additional members may be admitted to the Limited Liability Company upon the unanimous written consent of the then existing members. Capital contributions required of new members shall be determined as of the time of admission to the Limited Liability Company.

A member's interest in the Limited Liability Company may not be sold or otherwise transferred except upon the unanimous written consent of the members of the Limited Liability Company, which consent may be unreasonably withheld.

#### ARTICLE IV - CONTINUITY OF BUSINESS

The Limited Liability Company shall be dissolved upon the death, bankruptcy, retirement, resignation, expulsion, or dissolution of any member or the occurrence of any other event which terminates the continued membership of a member; provided, however, that all the remaining members may consent to the continuance of the Limited Liability Company's business notwithstanding the death, bankruptcy, retirement, resignation, expulsion, or dissolution of any member or the occurrence of any other event which terminates the continued membership of a member.

The Limited Liability Company may be dissolved upon the unanimous written consent of the members of the Limited Liability Company.
