**FIRST:** The name of the Limited Liability Company is **STONELEDGE CONSERVATION & MASTER FRAMING, L.C.**


**SECOND:** The name of the Limited Liability Company shall be changed to **STONELEDGE/THE FINE ARTS CONSERVANCY, L.C.**
