**ARTICLES OF ORGANIZATION OF
C.A. GREINER & SONS, L.C.**

The undersigned members hereby certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

ARTICLE I

NAME

Members shall have the right to admit new members by unanimous consent of existing members. Contributions required of new members shall be determined as of the time of admission to the Company.

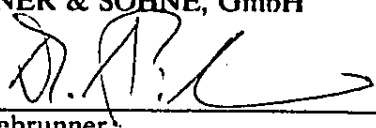
A member's interest in the Company may be sold or otherwise transferred but only after all the existing other members have consented and waived their right of first refusal as more fully set out in the Regulations.

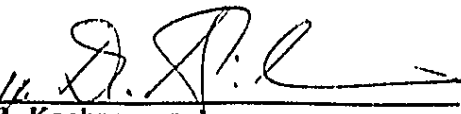
