**ARTICLES OF ORGANIZATION  
OF  
INTERNATIONAL COMMUNICATIONS NETWORKS, L.C.**

The undersigned, desiring to form a limited liability company, under the laws of the State of Florida, pursuant to Chapter 608, Fla. Stat., hereby subscribes to these Articles of Organization:

**ARTICLE I- NAME**

The name of this limited liability company ("Company") is INTERNATIONAL COMMUNICATIONS NETWORKS, L.C.

**ARTICLE II  
ADDRESS OF PRINCIPAL OFFICE**

The street address of the principal office of the Company is 266 Sand Dollar Road, Indialantic, FL 32903. The mailing address is P. O. Box 246, Melbourne, Florida 32902-0246.

**ARTICLE III - DURATION**

The duration of this Company commence upon the filing of these Articles of Organization and shall be perpetual.

**ARTICLE IV  
REGISTERED AGENT**

The name of the initial Registered Agent of the Company is John R. Kancilia, Esquire, whose street and mailing address is 1686 West Hibiscus Blvd., Melbourne, Florida 32901.

**ARTICLE V - PURPOSES**

This Company is organized to conduct any lawful business and shall have all of the powers as an individual to do all things necessary to carry out its business and affairs.

**ARTICLE VI  
ADDITIONAL MEMBERS**

Additional members may be admitted to the Company by a vote of two-thirds (2/3) of the number of votes entitled to be cast by members.

The terms and conditions of the admission of new members shall be determined by the vote of the members above described at the time of the admission.

#### ARTICLE VII DISSOLUTION

The death, insanity, bankruptcy, retirement, resignation, dissolution or expulsion of a member, including a manager who is a member, pursuant to these Articles or the regulations of the Company, shall terminate the continued membership of a member in the Company. Such termination of membership shall cause a dissolution of the Company, unless not less than two-thirds (2/3) of the votes entitled to be cast by members affirmatively elect, within forty-five (45) days of such occurrence, to continue the business of the Company by written consent or at a duly called meeting of the members.

#### ARTICLE VIII REGULATIONS

The power to adopt, alter, amend or repeal the regulations of the Company shall be vested exclusively in the members of the Company. Regulations may be altered or amended only by the vote or consent of members which would be sufficient to admit a new member.

#### ARTICLE IX MANAGEMENT

The Company shall be managed by a manager who shall be a member. The first manager is JACK ROSA whose address is 266 Sand Dollar Road, Indian Shores, FL 32903. A manager which is not an individual shall designate in writing to the Company the individual designated by it to act on its behalf.


#### ARTICLE X INDEMNIFICATION

The Company shall have the power to indemnify any manager to the fullest extent permitted by law.

#### ARTICLE XI AMENDMENT

These Articles may be amended only by the unanimous vote of the members.
