These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

1. Name. The name of this limited liability company is GROVER ENTERPRISES, L.C. (the "Company").

2. Duration. The Company shall exist from the date of filing these Articles with the Department of State until dissolved by the members or until the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by the unanimous consent of all of the remaining members.

3. Purpose. The limited liability company is organized for the purpose of transacting any and all lawful business authorized to limited liability companies under applicable law.

4. Mailing Address and Street Address. The mailing address and the street address of the principal office of the Company is:

6. Capital. The capital of this limited liability company is \$560,000. Additional capital contributions are not required, but may be made by the members in accordance with the terms of that certain Operating Agreement of GROVER ENTERPRISES, L.C.

7. Additional Members. Additional members may be admitted to the Company, but only if all of the then-current members agree to the admission of the additional members and to the terms of admission.

8. Termination of Membership. If a member of the Company dies, retires, resigns, is expelled or dissolved, experiences bankruptcy, or upon the occurrence of any other event

which terminates the continued membership of a member in the Company, the remaining members may, by unanimous written agreement, continue the business of the Company.

9. Management of the Company. The Company shall be managed by the members and the names and addresses of the managing members are:

11. Regulations. The members shall have the power to adopt, alter, amend, or repeal regulations of the Company containing provisions for the regulation and management of the affairs of the Company.

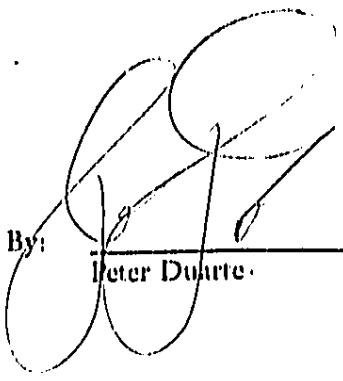

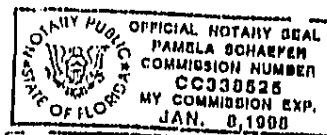

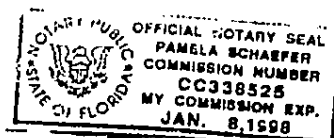
