ARTICLE I - Name

The name of the limited liability company is J.V. Argie , L.C.

ARTICLE II - Duration

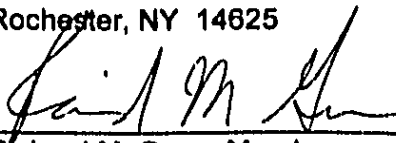

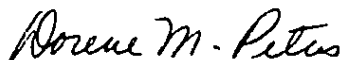
