AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF LINDRESORT L.C.

Pursuant to the Florida Limited Liability Company Act, Chap. 608, Florida Statutes, as amended from time to time (the "Act"), the following are adopted as the Amended and Restated Articles of Organization of the Lindresort L.C.:

ARTICLE I NAME
