ARTICLES OF ORGANIZATION

OF

C & D SANDS, L.L.C.

The undersigned, Donnell P. McKean and Cynthla McKean, acting as the organizers of C & D Sands, L.L.C., under the provisions of the Florida Limited Liability Company Act, (hereinafter sometimes the Act) adopt the following Articles of Organization for C & D Sands, L.L.C.:

ARTICLE I

NAME

1.0 The name of the limited liability company herewith organized by him is C & D Sands, L.L.C. (hereinafter sometimes the Company).

ARTICLE II

DURATION

2.0 The duration of the Company shall be for thirty (30) years from date of the filing of these Articles of Organization in the Office of the Florida Department of State, unless the Company is earlier dissolved pursuant to the actions of its members or by operation of the Act.

ARTICLE III

PURPOSES

- 3.0 The purposes for which the Company is organized are:
- 3.1 To engage generally in the business of buying, selling, dealing in and with real estate; and in addition thereto the Company shall be authorized and empowered to engage in any lawful business or enterprise not prohibited by the Act or by law; and
- 3.2 In general, to do everything necessary, proper, advisable or convenient for the accomplishment of the purposes stated in this Article, and to do all things incidental to them or in connection with them that are not forbidden by the Act, by other laws, or by these Articles of Organization.

ARTICLE IV

PRINCIPAL OFFICE; REGISTERED OFFICE AND REGISTERED AGENT

- 4.0 Principal Office. The mailing address and street address of the principal office of the corporation is 118 Woodiawn Drive, Panama City Beach, Fiorida, 32407.
- 4.1 Registered Office and Registered Agent. The address of the initial registered office of the Company is 118 Woodlawn Drive, Panama City Beach, Florida, 32407. The name of its initial registered agent at such address is Donnell P. McKean.

ARTICLE V

MEMBERS

5.0 The names and mailing addresses of the initial members of the Company are as follows:

ARTICLE VI

ADDITIONAL MEMBERS

- 6.0 Admission to Membership. From the date of the filing of these Articles in the Florida Department of State, any person or entity acceptable to the Members by their unanimous vote may become a member in this Company either by the issuance by the Company of membership interests for such consideration as the Members by their unanimous votes shall determine, or as a transferee of a Member's membership interest or any portion thereof, subject to the terms and conditions of any Operating Agreement adopted by the Members.
- 6.1 Financial Adjustments. No new members shall be entitled to any retroactive allocation of losses, income or expense deductions incurred by the Company. The managers may, at their option, at the time a member is admitted, close the Company's books (as though the Company's tax year had ended) or make pro rata allocations of loss, income, and expense deductions to a new member for that portion of the Company's tax year in which a member was admitted in accordance with the provisions of §706(d) of the Internal Revenue Code of 1986 and the U. S. Department of Treasury Regulations promulgated thereunder.

ARTICLE VII

RIGHTS TO CONTINUE BUSINESS OF COMPANY

7.0 The remaining members of the Company shall have the right to continue the business of the Company after an event of dissociation terminates the continued membership of a member in the Company in accordance with the terms and provisions of any Operating Agreement adopted by the members.

ARTICLE VIII

MANAGEMENT OF COMPANY

8.0 The business and affairs of the Company shall be managed by its manager. The manager shall direct, manage, and control the business of the Company to the best of their ability. The Company shall initially have one manager. The number of managers shall be subject to change from time to time by the affirmative vote of the members holding at least two-thirds of all of the capital interests in the Company's capital, but in no instance shall there be less than one manager. Each manager shall hold office until the next annual meeting of the members or until a successor shall have been elected and qualified. Managers shall be elected by the affirmative vote of members holding at least a majority interest. Managers need not be residents of the State of Florida or member of the Company.
