# SANTA FE STUDIO, L.C.



The undersigned for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I

NAME - The name of the limited liability company shall be SANTA FE STUDIO, L.C. ("Company"). The principal place of business of the Company in Florida shall be Naples, Florida.

## **ARTICLE II**

<u>DURATION</u> - The Company shall commence its existence on October 31, 1996. The Company's existence shall be perpetual, unless the Company is earlier dissolved or terminated as provided in these Articles of Organization.

## ARTICLE III

<u>PURPOSES AND POWERS</u> - The general purpose for which the Company is organized is to engage and transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

#### **ARTICLE IV**

MAILING ADDRESS AND STREET ADDRESS - The mailing and street address of the principal office of the Company is 300 Pirates Bight, Naples, Florida 34103.

#### **ARTICLE V**

REGISTERED OFFICE AND AGENT - The name and address of the registered agent of the Company in the state of Florida is Larry Portner, 300 Pirates Bight, Naples, Florida 34103.

# **ARTICLE VI**

<u>CAPITAL CONTRIBUTIONS</u> - The members of the Company shall contribute to the capital of the Company the cash or property set forth in Exhibit "A".

## **ARTICLE VII**

ADDITIONAL CAPITAL CONTRIBUTIONS - Each member shall make additional capital contributions to the Company only upon the unanimous consent of all the members.

## **ARTICLE VIII**

ADMISSION OF NEW MEMBERS - No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and upon such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

#### **ARTICLE IX**

TERMINATION OF EXISTENCE - The Company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of the member, or manager, or upon the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there are at least two remaining members.

## **ARTICLE X**

MANAGEMENT - The Company shall be managed by a manager in accordance with the regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with the law or these Articles of Organization. The name and address of the initial manager of the Company is Larry Portner, 300 Pirates Bight, Naples, Florida 34103.




