**ARTICLES OF ORGANIZATION
OF

THE UNDERSIGNED, pursuant to the provisions of the Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company (the "Limited Liability Company") under the laws of the State of Florida does hereby set forth the following:

**ARTICLE I- NAME OF LIMITED LIABILITY
COMPANY**

The name of the Limited Liability Company shall be **SECURE SEAL-ORLANDO, L.C.**

ARTICLE II- PERIOD OF DURATION

The period of duration of the Limited Liability Company shall be thirty (30) years from the date these Articles of Organization are filed with the Department of State or until the Limited Liability Company is dissolved pursuant to provisions of the Act, whichever is the first to occur.

ARTICLE III- PRINCIPAL OFFICE, MAILING ADDRESS

The principal place of business and mailing address of the Limited Liability Company is **1221 West Colonial Drive, Suite 100, Orlando, Florida 32804.**

**ARTICLE IV- INITIAL REGISTERED OFFICE
AND AGENT**

The street address of the initial registered office of the Limited Liability Company is **1221 West Colonial Drive, Suite 102, Orlando, Florida 32804** and the name of the initial registered agent at that address is **Ometrias Deon Long.**

ARTICLE V- GENERAL PURPOSE AND POWERS

The purpose for which the Limited Liability Company is organized is to engage in any and all businesses and activities permitted by the laws of the State of Florida to be engaged in by a limited liability company organized and existing under the Act. The Limited Liability Company shall also have all of the powers vested in a limited liability company organized and existing under the Act.

ARTICLE VI- MANAGEMENT

The management of the Limited Liability Company shall be vested in its members in proportion to their contributions to the capital of the Limited Liability Company, as adjusted from time to time to properly reflect the additional contributions or withdrawals of such members.

ARTICLE VII- INITIAL MEMBERS

ARTICLE VIII- ADMISSION OF ADDITIONAL MEMBERS

ARTICLE IX- DISSOLUTION

Upon the death, bankruptcy, retirement, expulsion or dissolution of a member of the Limited Liability Company, the Limited Liability Company shall be dissolved in accordance with the provisions of the Act, provided however, that the remaining members may consent to continue the business of the Limited Liability Company by the affirmative vote of members whose capital accounts in the aggregate constitute sixty-seven percent (67%) or more of the total capital accounts of all of the members of the Limited Liability Company.

ARTICLE X- ADDITIONAL CONTRIBUTIONS

No additional contributions have been agreed to at the date of filing of these Articles of Organization. Additional contributions, if any, will be made upon unanimous agreement by all of the members of the Limited Liability Company.

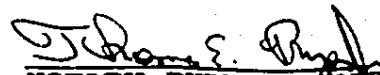
