**CERTIFICATE OF AMENDMENT
TO THE ARTICLES OF ORGANIZATION OF
TOC SPECIALISTS, L.C.**

Pursuant to the provisions of Section 608.411 and Section 621.13 of the Florida Statutes, TOC Specialists, L.C. (the "Company"), adopts the following Certificate of Amendment to its Articles of Organization. The Articles of Organization were filed November 8, 1996.

1.

Article I of the Articles of Organization shall be amended to read:

"NAME. The name of the Limited Liability Company is TOC Specialists, P.L. (hereinafter the "Company")."

2.

Article IV of the Articles of Organization shall be amended to read:

"ARTICLE IV

MANAGEMENT. The Company shall be managed by a manager and the name and address of such manager to serve as manager is:

Suite 400
Tallahassee, Florida 32300"

3.

The Articles of Organization shall be amended to add the following Article V:

"ARTICLE V

INITIAL REGISTERED AGENT. The initial registered agent shall be:

Tallahassee, Florida 32301.

The initial registered agent has executed a statement of acceptance of his appointment as Registered Agent in accordance with Florida Statutes § 608.407(d)."

4.

The Articles of Organization shall be amended to add the following Article VI:

"ARTICLE VI

ADMISSION AND TERMINATION OF MEMBERS. The following are set forth in the Operating Agreement of the Company, which shall be on file at the principal address of the Company: (a) the right of Members to admit additional members; (b) the terms and conditions of admission of new members; (c) the right of the remaining members of the Company to continue the business of the Company on the death, retirement, resignation, expulsion, or bankruptcy of a member or the occurrence of any other event which terminates the continued membership of a member in the Company."

5.

The Articles of Organization shall be amended to add the following Article VII:

"ARTICLE VII

NATURE OF BUSINESS. The Company is organized for the purpose of rendering professional services in accordance with Section 621.06 of the Professional Service Corporation and Limited Liability Company Act, and the Company shall have all powers necessary to conduct said business and all other powers enumerated in the Florida Professional Service Corporation and Limited Liability Company Act or under any act amendatory thereof, supplemental thereto or substituted therefor." "Practice of Medicine."

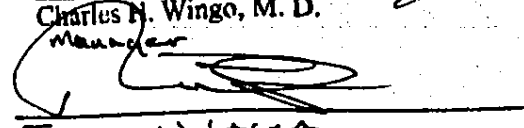
These amendments were duly adopted by the vote of the Members and Manager of the Company on November 11, 1996.
