

# ARTICLES OF ORGANIZATION OF CT MARITIME SERVICES, L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act; Florida Statutes Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

# 1. NAME

The name of the limited liability company is CT Maritime Services, L.C. (the "Company").

### 2. PERIOD OF DURATION

The Company's period of duration shall be perpetual, or until dissolved in a manner provided by law, or until otherwise dissolved under these Articles of Organization or the regulations adopted by the members.


