**Articles of Organization

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I- Name**

The name of the limited liability company (the "Limited Liability Company") is:

**ARTICLE II-Address**

**Article III- Duration**

The limited Liability company shall commence its existence on the date that these Articles of Organization are filed by the Florida Department of State. The existence of the Limited Liability Company shall terminate on that date which is thirty (30) years from the date of the commencement of its existence, unless the Limited Liability Company is earlier dissolved as provided in theses Articles of Organization.

**ARTICLE IV-Purposes and Powers**

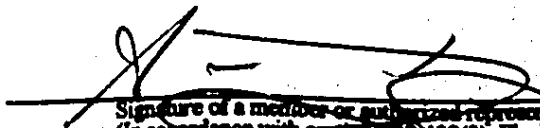
