ARTICLES OF ORGANIZATION

OF

HERCULETE LIMITED COMPANY

I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Organization for the purpose of creating a company under the laws of the State of Florida.

ARTICLE I NAME and PRINCIPAL OFFICE

The name of this company shall be HERCULETE LIMITED COMPANY, a Florida Limited Liability Company, and the principal place of business and mailing address of this company shall be: 6262 Bird Road, Suite 31, Miami, Florida 33155.

ARTICLE II DURATION

This company shall commence its existence immediately upon the filing of these Articles of Organization and shall exist perpetually thereafter unless sooner dissolved according to law.

ARTICLE III PURPOSE

This company may engage in any activity or business permitted under the laws of the State of Florida.

ARTICLE IV CAPITALIZATION

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

The consideration for all of the said stock shall be payable in cash, property, real or personal, labor or services in lieu of cash, at a just valuation to be fixed by a board of the members ("Board of Members") of the company.

Upon the sale for cash of any new stock of the same kind, class or series as that which he already holds, every member of this company shall have the pre-emptive right to purchase his pro rata share thereof at the price which it is offered to others, whether or not in excess of par.

Fractional shares need not be issued on account of this provision.

ARTICLE Y INITIAL REGISTERED OFFICE AND AGENT

- A. - B. Dealing with other companies, persons or entities: Without incurring any liability to the company or any of its members, any Member, officer or member of this company may be an officer, Member, member or partner of any other entity or transact any business whatsoever with any other entity even where said other entity is in direct or indirect competition with this company.

Furthermore, there shall be no obligation to disclose any such transaction or business arrangement to this company.

ARTICLE IX NO MEMBER LIABILITY

The private property of the members shall not be subject to payment of the corporate debts in any extent.

ARTICLE X INDEMNIFICATION

This company shall indemnify its officers, Members and employees to the fullest extent permitted by law, either now or hereafter in effect.
