NAME

The name of the limited liability company shall be STAT Auditing Software, L.C.

RESTRICTIONS ON MEMBERSHIP

Members shall have the right to admit new members upon the affirmative vote of a Majority Interest of the members (as such term is defined in the operating agreement of the limited liability company).
