ARTICLES OF ORGANIZATION FOR

CLAUDICA, L.C.

ARTICLE I

NAME

The name of the Limited Liability Company is Claudica, Lic

ARTICLE II

ADDRESS

The mailing address and the street address of the principal office of the Limited Liability Company is 806 South Dixie Highway, Hollywood, Florida 33020.

ARTICLE III

MENDERS

The company shall have three initial members, CLAUDETTE DELHUSEA, SOIA MASHASAN and MONICA RUSSO. The number of members may be increased from time to time in a manner provided by the regulations, but shall never be less than two.

ARTICLE IV

PURPOSE

The company is organized for the purpose of transacting any and all lawful business, including the purchase and management of real estate, with such powers to do all things necessary to carry out its business and affairs.

ARTICLE V

DURATION/CONTINUATION

Beginning on the date these Articles of Organization are filed with the Florida Department of State, the period of the Company's duration shall be perpetual, unless terminated by the

unanimous written agreement of all members or by the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member, unless the business of the company is continued by the consent of all the remaining members, or by amendment of these Articles of Organization providing for the continued existence of the Company subsequent to the forgoing events.

ARTICLE VI

MANAGEMENT

ARTICLE VII

ADMISSION OF ADDITIONAL MEMBERS

The right, if given, of the remaining members to admit additional members and the terms and conditions of the admissions shall be upon unanimous written consent by all members.

Contributions required of new members shall be determined as of the time of admission to the Company. A member's interest in the Company may not be sold or otherwise transferred except with unanimous written consent of all members.

ARTICLE VIII

COMERC

All limited liability company powers shall be exercised by or under the authority of, and the business and afrairs of this limited liability company shall be managed under the direction of the members of the company. Any amendment to these Articles of Organization shall be on such form prescribed by the Florida Secretary of State, containing such terms and provisions consistent with Section 608 of the Florida Statutes, as shall be prescribed by the Department of State, and shall be signed and sworn to by all members of the Company. In the event a new member is added by such amendment, it shall also be signed by the member to be added.
