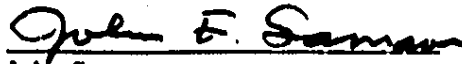

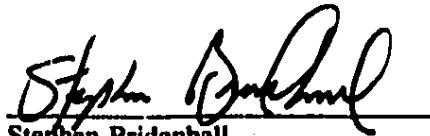
The right of the members to admit additional members and the terms and conditions of the admissions shall be upon unanimous agreement of the two managing members.

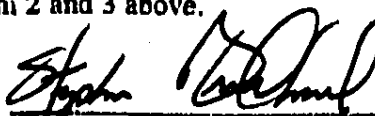
