ARTICLES OF ORGANIZATION

ARTICLE I. Name

The name of this limited liability company is Green Point Construction, L.C. ("the Company").

ARTICLE II. Address of Principal Office

The mailing and street address of the principal office of the Company is 865 Highway 98, Eastpoint, Florida 32328-0922.

ARTICLE III. Duration

The duration of the Company shall be twenty (20) years.

ARTICLE IV. Initial Registered Agent and Address

The name and street address of the initial registered agent of the Company is John P. Dodds, 865 Highway 98, Eastpoint, Florida 32328-0922.

ARTICLE V. Management

The Company is to be managed by a manager, and the name and address of such manager is John P. Dodds, 865 Highway 98, Eastpoint, Florida 32328-0922.

ARTICLE VI. Admission of Additional Members

No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and upon such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or to become a member unless all the other members of the Company, other than the member proposing to dispose of his or her interest, approve of the proposed transfer by unanimous written consent.

ARTICLE VII. Members' Rights to Continue Business

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or upon the occurrence of any other event that terminates the continued membership of a member in the Company, the remaining members of the Company shall have the right to continue the business of the Company, provided that all remaining members consent to the continuation and there are at least two remaining members.
