## CASTLE CARPET, L.C. ARTICLES OF ORGANIZATION

The undersigned, pursuant to the provisions of Chapter 608, Florida Statutes, for the purpos of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

#### **ARTICLE I**

#### **NAME**

The name of the Limited Liability Company is Castle Carpet, L.C.

# **ARTICLE II** PERIOD OF DURATION

majority in interest of the remaining Class A members of the Limited Liability Company.
